One month prior to your wedding your final balance is prepared and settlement of your account is required in full.

STEP 1

Contact our Event Co-ordinator to confirm your date and submit your deposit of *£400.00 *which is non refundable. Your Wedding Ceremony and arrangements will be confirmed in writing once we have received a completed and signed copy of the booking form entitled:

STEP 2

4 months prior to your wedding you will be expected to pay the second installment of *£400.00 (*non refundable) and our Event Co-ordinator will be in touch to discuss your requirements and any special requests that you may have.

STEP 3

1 month prior to your wedding, we will arrange a meeting to confirm menu requests and final numbers. During this meeting your final account will be prepared and calculated based upon your arrangements where full and final settlement will be expected.
